SUBJECT: Bills under consideration by committee on June 10<sup>th</sup>

On behalf of Pennsylvania's borough communities I wanted to contact members of the Senate Local Government Committee regard several bills pending consideration by the committee. Among those bills under review PSAB would offer the following perspective and position:

**Senate Bill 775** (P0834) sponsored by Senator Eichelberger seeks to reenact the Third Class City Code and place it into the Pennsylvania Consolidated Statutes as Part V of Title 11 Cities. This is similar to what PSAB did with the Borough Code last session when it moved its code into PaCS as Title 8 Boroughs & Incorporated Towns. **PSAB supports the measure** and the benefits it will provide its members resulting from the consolidation.

**Senate Bill 792** (P0953) sponsored by Senator Wozniak plainly amends the 1<sup>st</sup> Class Township Code to insure that any building codes and property maintenance codes created under Act 45 by the township will remain in force should the Act in the future be repealed.  
**PSAB supports the bill.**

**Senate Bill 793** (P0954) sponsored by Chairman Hutchinson amends the 2<sup>nd</sup> Class Township Code to insure that any building codes and property maintenance codes created under Act 45 by the township will remain in force should the Act in the future be repealed.  
**PSAB supports the bill.**

**Senate Bills 871** (P1005), **872** (P1006), **873** (P1007) all sponsored by Senator Eichelberger amend the First & Second Class Township Codes as well as Title 8 Boroughs to allow for gifts of a de minimis amount to recognize the service or passing of municipal officials, employees or community volunteers. This measure will clarify the municipality's ability to offer congratulatory recognition for those who either have served or continue to serve the community. **PSAB supports the bill.**
